

The Steuben County Market Animal Project Award will be awarded to a current 4-H member participating in the Sale Program, that are 17 or 18 years old as of January 1st of the current year. This youth will need to apply by the deadline and has met all the criteria below. The recipient of the Award will receive \$1000 from the Steuben County 4-H Market Animal Funds.

CRITERIA:

- Applicant must have shown/sold an animal at least 2 years and sold an animal at least one of those years in the Steuben County 4-H Markey Animal Sale.
- Applicant must be 17 or 18 years old as of January 1st of the current year.
- A Youth may only win this Award once.
- Must have filled out the application in full and submitted it by the set deadline.
- The finalist will be required to participate in a personal interview with the Selection Committee prior to the selection of recipients.
